Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 15 3-302.11(A)(1); Priority; Observed raw eggs stored above cooked RTE (ready-to-eat) foods in the reach-in cooler. Separate raw animal foods from RTE foods and washed/unwashed fruits and vegetables to prevent cross contamination. CDI- eggs moved to lower shelf.
- 49 4-601.11 (B) and (C); Core; Black residue observed on the fan covers in the reach-in cooler. The nonfood-contact surfaces of equipment shall be kept free of residue accumulation. Increase cleaning frequency. All other surfaces observed clean. Full point not taken today.
- 56 6-403.11; Core; Open beverage container was observed on prep table above facility produce. Another employee beverage was stored on a prep counter near clean equipment. Utilize a designated area to store employee food and drink where contamination of food, clean equipment and single-service articles cannot occur. CDI- cups moved to lowest non-working shelf.
6-303.11; Core; Two light bulbs are burnt out over the grill hood and a fluorescent light is out above the warewashing area. Provide adequate lighting by replacing these bulbs.
