Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 45 4-903.11; Core; Observed single-use food cups and trays stored on a shelf with some dust and food debris. Store single-use and single-service articles in a clean, dry location; where they are not exposed to splash, dust, or other contamination; and at least 6 inches above the floor. CDI- shelf cleaned.
- 4-903.11; Core; Observed small, single-use food cups stored outside their packaging with the food-contact surface exposed. Single-Service and Single-Use items shall be kept in the original protective package or stored by using other means that afford protection from contamination until used. CDI- items inverted.
- 49 4-601.11 (B) and (C): Core; Some dust and food crumbs observed on a shelf where single-use articles are stored. The nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue and other debris. CDI- shelf cleaned. No point taken.
