

Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 5 2-501.11; Priority Foundation; No bodily fluid clean-up procedures were available for review. A food establishment shall have written procedures for employees to follow when responding to vomiting or diarrheal events. CDI- educational material provided.
- 16 4-501.114; Priority; Warewashing sink sanitizer measured below 200ppm Quaternary ammonium. Maintain sanitizer at correct concentration when used to sanitize. CDI- Quat was remade to correct concentration. Employees are still getting acclimated to the new equipment. No points taken today.
- 43 3-304.12 (A); Core; Food scoop handles laying inside food containers on makeline. In-use utensils in TCS food, must be stored with handles above the food and top of the food container. CDI- scoop handles removed from food.
- 45 4-903.11(C); Core; Single-use cups stored above the rim of the dispenser near register with the lip-contact portion exposed. Single-Service and Single-Use items shall be kept in the original protective package or stored using other means that protect the item until used. CDI- excess cups removed from dispenser.
