Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 2 2-102.12 (A); Core; At the time of inspection there wasn't a certified food protection manager. The person in charge shall be a certified food protection manager who has shown proficiency of required information through passing a test that is part of an accredited program.
- 16 4-601.11 (A); Priority Foundation; Several food storage containers on the clean equipment shelf were observed with visible stickers and sticker residue on the outsides. Containers are stacked together so that the inside of one container touches the exterior of another. Equipment food-contact surfaces shall be clean to sight and touch. Corrected During Inspection - containers were cleaned. Advised PIC to clean these further and remove all sticker residue prior to storing. No points taken today.
- 49 4-601.11 (B) and (C); Core; Reach-in units have visible residue accumulation on the bottom. The nonfood-contact surfaces of equipment shall be kept free of dust, dirt, food residue and other debris accumulation. Increase cleaning frequency.
- 53 6-501.18; Core; Men's bathroom toilet has visible residue on the seat. Maintain plumbing fixtures in clean condition.
- 55 6-501.12; Core; Floor under reach-in cooler in the lobby at hotdog station is visibly soiled. Physical facilities shall be maintained clean. Please pull out this unit more frequently and clean the floor.
