Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 28 7-201.11; Priority; Observed cleaning tablets stored above bins of sugar packets in the cabinet. Store chemicals away from food and in a manner that prevents contamination of food, single-service articles and clean equipment. CDI- tablets moved to a new location. These are dry tablets in a sealed container so risk of spilling is low. However, follow chemical storage requirements for all chemicals. No point taken.
- 49 4-601.11 (B) and (C); Core; The fan cover in the reach-in cooler is dusty. The nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue and other debris. Increase cleaning frequency.
