Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 10 5-202.12; Core; The 'hot' water handle at the handwashing sink by the dish area is in dis-repair. Water is unable to dispense. The 'cold' water handle is functional. A handwashing sink shall be equipped to provide water at a temperature of at least 100 F through a mixing valve or combination faucet. Repair handle, ensure 100 F minimum can be reached and both handles are functioning as intended.
- 16 4-601.11 (A); Priority Foundation; Clear, plastic containers stored as clean soiled with food debris and sticker residue. Equipment, food contact surfaces and utensils shall be clean to sight and touch. CDI - Items moved for thorough cleaning.
- 28 7-102.11; Priority Foundation; A few spray bottles of cleaner/chemicals unlabeled. Working containers used for storing poisonous or toxic materials shall be labeled. CDI - Spray bottles to be labeled by PIC.
- 44 4-903.11(A), (B) and (D); Core; Containers holding clean utensils and lids soiled with debris. Cleaned equipment and utensils shall be stored in a clean location.
- 47 4-501.12; Core; The large red and white cutting boards are stained and scored. Cutting surfaces shall be replaced or resurfaced once no longer easily cleanable. Replace/resurface if unable to remove soil.
