### Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 22 3-501.16(A)(2); Priority; Observed cut melon on the salad bar holding between 42 and 46F. Maintain TCS foods in cold holding at 41F or less. CDI- melon moved to walk-in cooler. Do not store TCS foods above the fill line of containers to ensure they stay sufficiently cold.
- 44 4-903.11 (A), (B), and (D); Core; A few metal food pans were stored on the clean equipment shelf stacked wet. After cleaning and sanitizing, store equipment and utensils in a self draining position that allows air drying. CDI- pans separated for drying. No point taken.
