Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 49 4-601.11(Core) The shelves in the walk in cooler had food residues on them. The drain board on the 3-compartment sink had some residue, under the drying rack. Keep non food contact surfaces of equipment clean to avoid build up of dust, food residue or debris.4-602.13 Non food contact surfaces of equipment shall be cleaned frequently to preclude accumulation of soil residues. Increase cleaning frequency of these areas. PIC stated they will clean them after lunch.
