Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 36 4-302.12; Priority Foundation; The thermometer used for taking temperatures of food is not working as intended. When turned on, nothing populated on the display screen. Batteries appear to be dead. Food temperature measuring devices shall be provided and readily accessible for use in ensuring attainment and maintenance of food temperatures. CDI - PIC adjusted thermometer during inspection and thermometer began to work; however, PIC to obtain an additional working food thermometer.
- 49 4-601.11(B) and (C); Core; Walk-in cooler fan guards and prep room fan guards soiled with dust. Non-food contact surfaces shall be kept free of accumulation of food residue, dirt, dust, and other debris.

Additional Comments

Replace the shrink wrap pad (at the station that is less frequently/not frequently used). Pad is torn in multiple areas.
