Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 15 3-302.11 (A)(2); Priority; Observed trays of raw chicken stored above trays of goat meat in the display cooler. Separate types of raw animal foods from each other such as beef, fish, lamb, pork, and poultry during storage, preparation, holding, and display to prevent cross contamination. Follow stacking order as seen on educational sticker. CDI- meat rearranged. Full points taken for repeat violation.
- 28 7-201.11; Priority; Observed a bottle of Tylenol and acetone stored on a shelf directly above the meat wrapping station. Poisonous or toxic materials shall not be stored above food, clean equipment or single-use articles. CDI- materials removed.
- 45 4-903.11: Core; Observed single-use meat trays stored on a soiled shelf and with the food-contact surface exposed. Single-Use items shall be kept in the original protective package or stored by using other means that afford protection from contamination until used. Store single-use articles in a clean, dry location where they are not exposed to splash, dust or other contamination. CDI- shelf cleaned and trays inverted.
- 55 6-501.12; Core; Observed dust and debris on the floor behind the white chest freezer in the meat prep room. Physical facilities shall be maintained clean. Floor swept during inspection. No point taken.
