Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 35 3-501.13 (E); Core; Observed thawed tuna still sealed in its packaging in the walk-in cooler. Reduced oxygen packaged fish, required to be kept frozen until time of use per labeling, shall be removed from the reduced oxygen environment prior to thawing under refrigeration or upon completion of thawing using running water. CDI- packs cut open.
- 49 4-601.11 (B) and (C); Core; Sliding door tracks to storage compartment below display case are soiled with visible residue/debris. Inside of storage cabinet also needs cleaning. The nonfood-contact surfaces of equipment shall be kept free of dust, dirt, food residue and other debris accumulation. Increase cleaning frequency. All other surfaces and equipment observed clean. Full point not taken.
